FIRST PHASE ALLOTMENT TO ENGINEERING, ARCHITECTURE
COURSES PUBLISHED & ACTIVITES RELATED TO SECOND PHASE
ALLOTMENT STARTED

The first phase allotment to Engineering, Architecture courses in the State for the year 2022 is published on the website www.cee.kerala.gov.in. The allotment is based on the online options registered by the candidates from 14.09.2022 to 20.09.2022, 10.00 AM through the above website. Candidates under Persons with Disabilities (PD), Minority Community seats (except Muslim), Registered society/Registered Trust quota/wards of Co-operative Employees quota seats in Private Self Financing /Government Cost - Sharing Engineering colleges are not included in the list.

FIRST PHASE ALLOTMENT

The details of allotment will be available on the home page of the candidate. The candidates should take a printout of the allotment memo, which shows the details such as Name, Roll Number, allotted course, allotted college, category of allotment, details of fee to be paid etc.

Those candidates who have got an allotment shall have to remit the fee to be paid to the Commissioner for Entrance Examinations as specified in the first phase allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** from **23.09.2022 to 26.09.2022, 3.00 PM** in order

to accept the allotment. The list of Post Offices is available in the website. Those candidates who do not remit the fee on or before the date prescribed for the same will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs. The options once lost will not be available in the subsequent phases.

In the first phase allotment, the students allotted to Engineering, Architecture courses need not physically join the Colleges.

1stPhase Allotment Schedule for Fee Payment

23.09.2022	Fee payment starts (through online/Head Post Offices)
26.09.2022, 3.00 PM	Fee payment facility ends.

Note:

1. Cyber Physical Systems, Computer Science and Engineering (Data Science) in Govt. Engineering College Thrissur, Civil Engineering, Electrical & Electronics Engineering, Mechanical Engineering in Malabar Institute of Technology Anjarakandi, Kannur, Robotics and Automation Engineering in Sree Buddha College of Engineering, Alappuzha have not been included in the first phase allotment.
2. Candidates got allotment in Government Engineering Colleges under the Directorate of Technical Education shall have to pay the Rs. 1000/- as caution deposit along with the tuition fee (except SC/ST/OEC). The token fee of Rs.1000/- paid by the SC/ST/OEC candidates will be adjusted in caution deposit.

ACTIVITIES RELATED TO SECOND PHASE ALLOTMENT

Step 1: Option Confirmation is mandatory:-

Candidates who got allotment and remitted the required fee and candidates who have not got any allotment in the first phase shall have to make online option confirmation if they want their higher order options in Engineering/Architecture courses are to

be considered in the second phase of allotment. For this, candidates shall have to log into their Home page and confirm their options by clicking the '**confirm**' button available therein.

Step 2: After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges, if any, from **24.09.2022** to **27.09.2022, 3.00 PM**, through the website **www.cee.kerala.gov.in**. Candidates can register options in the newly included Self financing Architecture Colleges given in the Annexure. Those who do not confirm their options online will not be considered for the second phase allotment and also their higher order options in Engineering, Architecture streams will not be available in the subsequent phases. If the candidate do not confirm his/her options the existing allotment shall be retained as per the first phase allotment. Online Option Confirmation is mandatory for being considered in the second phase of allotment for both candidates allotted with a course in the first phase and those who have not received any allotment in the first phase .

Those candidates who do not remit the fee on or before the date prescribed for the same will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs irrespective of the Option Confirmation Status.

Step 3: On the basis of options received up to **3.00 PM** on **27.09.2022**, the second phase allotment to Engineering, Architecture courses will be published on **30.09.2022**.
