However, the management reserves the right to alter the cut off percentage upward in the event of the number of applicants being large vis-à-vis our requirement of candidates.

Candidates have to be medically fit as per the corporation's standards. The selected candidates will have to undergo a medical test before joining the organization.

6.00 & (+) 4.00.

- Color blindness or squint, partial or full, is not acceptable in any case

- Any major medical ailment will debar a candidate from being eligible for the job.

The above mentioned medical standards are indicative and not exhaustive.

We would also like to advise you that as per the Government directives, a person seeking appointment on the basis of reservation to SC/ST/PWD & OBC (non-creamy layer) should submit valid certificates issued by a competent authority (as per specimens enclosed). As regards to the OBC candidates, kindly note that they have to produce a certificate as a proof that he/she does not belong to Creamy Layer on the crucial date i.e. the date of interview or within a month, in case of selection.

The selection process will comprise of pre-placement talk (PPT), group discussions and personal interviews.

The selected candidates will be issued provisional appointment letters and will be required to clear the pre-employment medical examination prior to joining. They will be required to join immediately after the final semester examinations are over (sometime in June/July 2015) even if their results are not declared by that time. The final appointment and continuance will however, be subject to the candidates passing the Final Degree examination in the first attempt itself with 60% marks and above (or equivalent CGPA and above) for OBC candidates relaxable to 50% marks and above (or equivalent CGPA and above) for SC/ST/PWD candidates.

The candidates selected provisionally as "Management Trainee" will be placed in Job Group "A" on a basic salary of Rs. 24,900/- (Scale of Pay 24,900 - 50,500/-) on probation for period of one year.
