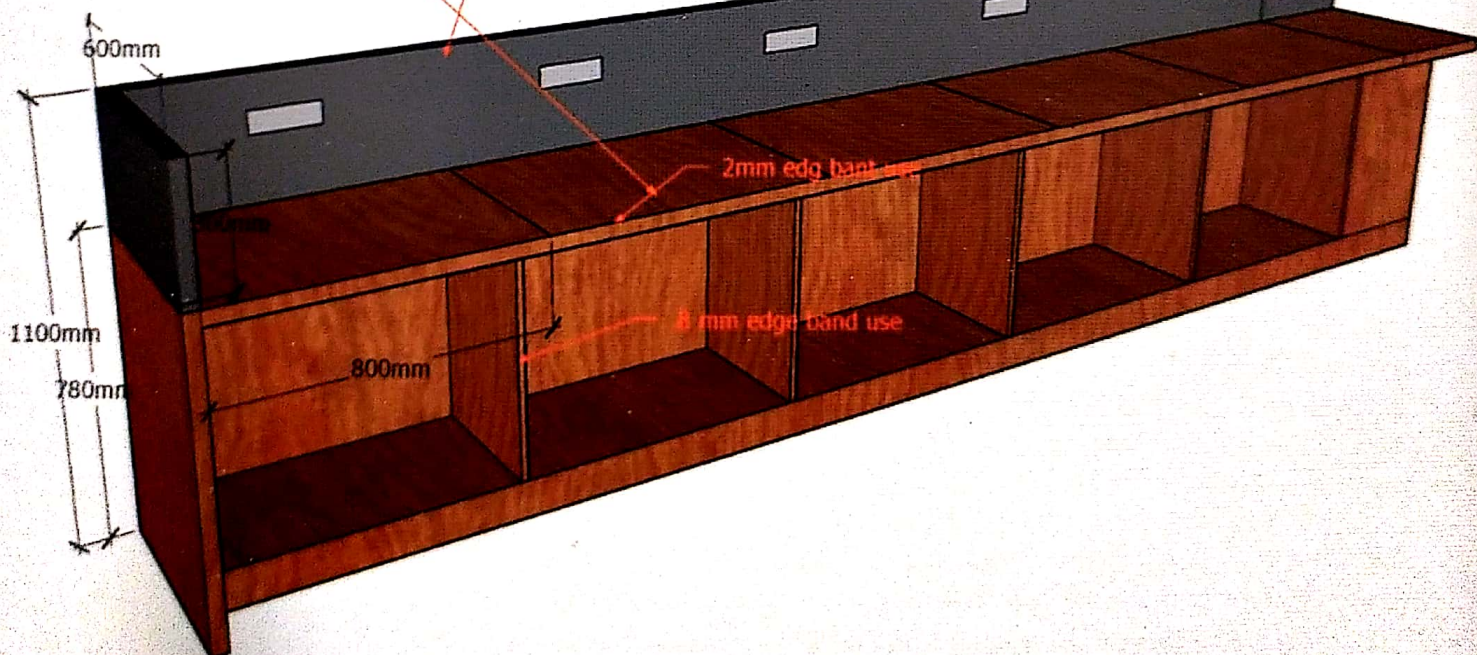

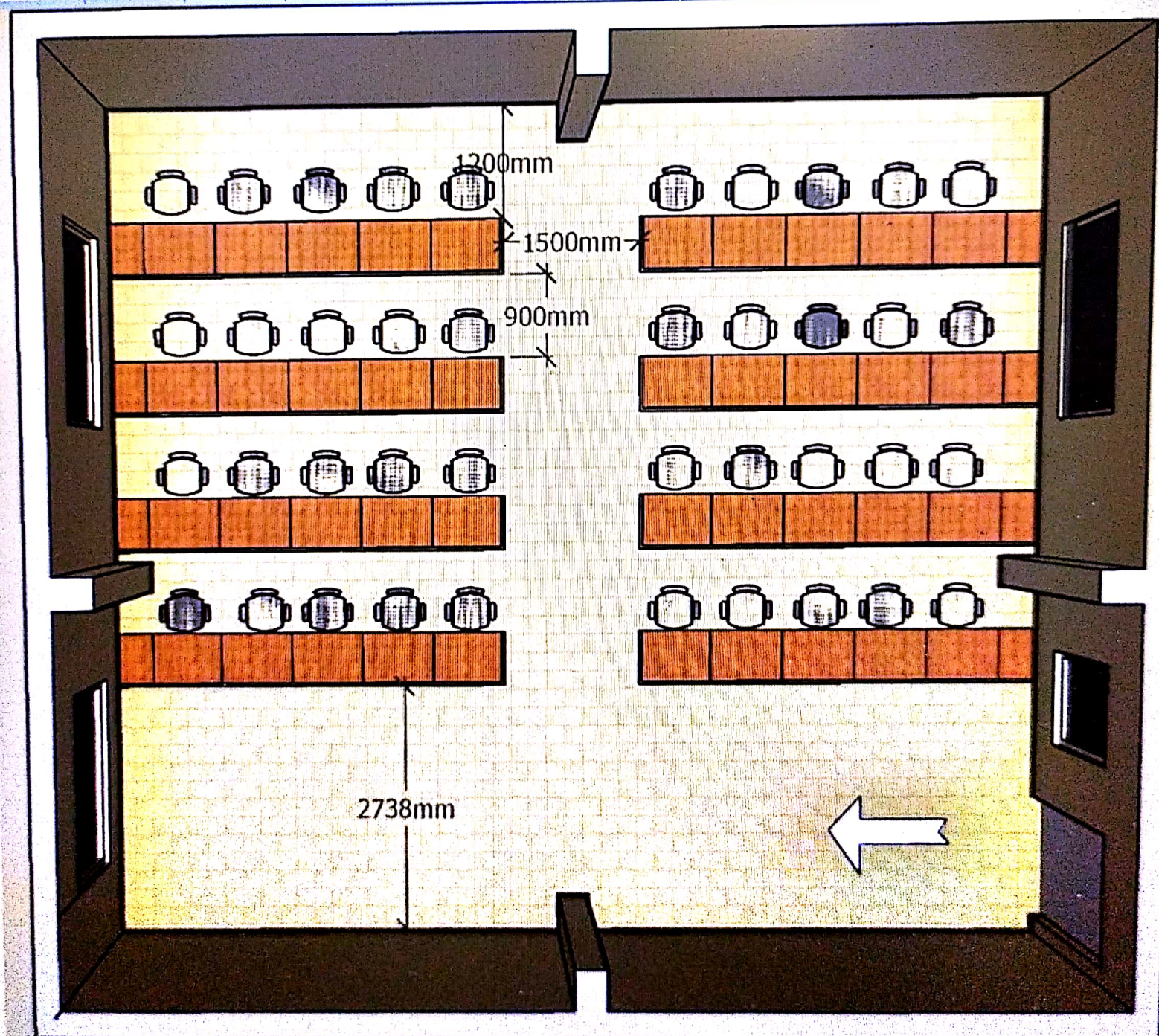

6. The cost of required materials will be given after supplying it, with proper tax bill. The balance amount of the contract will be paid after the satisfactory completion of the work.
7. If the Contractor fails to comply with or violate any terms and conditions of this agreement, he shall bound to forfeit to the HOD , Mecanical department , the entire contract amount with 12 % annual interest and the contract become automatically seized with immediate effect.
