Any faculty member whose name is in the Final Electoral Roll can be nominated for the Post 1.-COUNCIL MEMBER (GENERAL) and any female faculty member whose name is in the Final Electoral Roll can be nominated for the Post 2.- COUNCIL MEMBER (RESERVED FOR WOMEN). Every nomination shall be in the prescribed form and shall be made by an elector in writing /printed and shall be seconded by another elector. Every such nomination shall be accompanied by the consent of the nominee agreeing to serve on the College Council if elected. The Nomination paper must be submitted to Returning Officer, by the candidate him/her self in person with identity proof, in his office along on or before 12 noon on 09/02/2021 Proforma of the Nomination Paper is available in the Office of the Returning Officer or can be taken from official College Website .

Any candidate may withdraw his/her candidature by notice in writing signed by him/her and delivered in person or through messenger to the Returning Officer on or before 2.00 p.m. on 10/02/2021. Withdrawal once made shall be final. Proforma of the withdrawal of candidature form is available in the Office of the Returning Officer or can be taken from official College Website

The candidates or their agents, if any, appointed in writing and approved by the Returning Officer alone shall be permitted to be present on the occasions of scrutiny of nominations, polling and scrutiny and counting of votes.

Every elector in the Final Electoral Roll can cast at most two votes for the Post.1 - COUNCIL MEMBER (GENERAL) and at most one vote for the Post.2- COUNCIL MEMBER (RESERVED FOR WOMEN)
