College. However, the election to the post of Vice-Chairman (S.No.2) shall be elected by the entire student community, registered for the present academic semester ,of the college from among the women students.

The Posts mentioned in the S.No 7, 8,9,10,11,12,13,14, will be elected by and from among UG (B Tech) students of respective Branch and the Posts mentioned in the S.No 15, 16, 17, 18, 19, 20, 21, 22 will be elected by and from among PG (M Tech/ M Plan/ MCA) students of respective Branch registered for the present academic semester of the college . PhD students registered for the present academic semester of the college can cast their votes for the post PG DEGREE REPRESENTATIVE in the branch with which they are pursuing degree

The Posts mentioned in the S.No 23 will be elected by and from among the woman students of the college

Only those full-time regular students whose names are on the Electoral Roll are eligible to take part in the election. Requests, if any, for making any correction, alteration or deletion in the Electoral Roll shall be submitted to the Returning Officer within the time limit fixed.

Every elector shall be at liberty to nominate (propose) a qualified student to fill up a vacancy. No elector can nominate (propose) more than one candidate for one post. The

eligibility criteria prescribed by the Honourable Supreme Court of India shall strictly be followed. Every nomination shall be in the prescribed form and shall be made by an elector in writing, and shall be seconded by another elector. No elector can second more than one candidate for one post. Every such nomination shall be accompanied by the consent of the nominee agreeing to serve on the College Students' Union, if elected. The candidate shall furnish the required declarations on the Nomination Paper and then obtain the verification report from the concerned Head of the Department on the Nomination Paper. The Nomination paper must be submitted to Returning Officer, by the candidate him/her self in person with identity proof, in his office alone on or before the time limit. Proforma of the Nomination Paper is available in the Office of the Returning Officer or can be taken from official College Website. A candidate shall have one opportunity to contest for the post of office bearer, and two opportunities to contest for the post of an executive member.

Any candidate may withdraw his/her candidature by notice in writing/printed signed by him/her and delivered in person to the Returning Officer on or before the time limit. Withdrawal once made shall be final. Proforma of the withdrawal of candidature form is available in the Office of the Returning Officer or can be taken from official College Website

The candidates or their agents, if any, appointed in writing and approved by the Returning Officer alone shall be permitted to be present on the occasions of scrutiny of nominations, polling and scrutiny and counting of votes.

### **Eligibility criteria for Candidate, Proposer and Seconder**

1. Should be a fulltime regular student of the course
2. Have no academic arrears as on date
3. Have attained 75% of attendance in the previous semester except for the post the first semester student. The first year students should have 75% of attendance in the current semester
4. Have not been subjected to disciplinary proceedings by the College / University
5. Have not been tried/convicted of any criminal offence or misdemeanour

The Honourable Supreme Court of India have perused the Report of the Committee, headed by Mr. J. M. Lyngdoh, former Chief Election Commissioner, constituted by the Ministry of Human Resource Development, Government of India for making recommendations and suggestions relating to the Students' Union Elections in terms of the order of the Supreme Court dated 12.12.2005. The Supreme Court have accepted the recommendations as an interim measure and directed to implement the recommendations subject to such modifications indicated therein. The recommendations have been incorporated as a part of the order. The Supreme Court have also made it clear that the recommendations made, which the court have accepted to be adopted as an interim measure, shall be followed in all College/University Elections, to be held hereinafter, until further orders. The full text of the verdict of the Supreme Court forms part of this election notification. All the recommendations made by the committee and accepted by the Supreme Court are applicable to this election. The directives of the Supreme Court shall be supplementary to the clauses contained in the Constitution for College Unions and the rules for the conduct of elections to College Unions contained therein and the same shall supersede any of the clauses that are inconsistent with it.
